Sub: Introduction of supernumerary seats in the Non-AICTE courses running in the affiliated colleges conducting Non-AICTE courses.

Dear Sir/Madam,

I am directed to inform you the following:

Introduction of supernumerary seats over and above the affiliated intake per course in the Non-AICTE colleges affiliated to this University was under active consideration for some time past as the stakeholders were representing time to time before the University for Introduction of supernumerary seats in the Non-AICTE courses running in the affiliated colleges on account of the reasons stated hereunder:

- (i) Students dropped out after closing of admission in each academic session.
- (ii) Admission of Foreign Nationals/Overseas Citizen of India (OCI)/Persons of Indian Origin (PIO)/Children of Indian workers in Gulf Countries and Sons/Daughters of Non resident Indian(s).


Discussions were held time to time in different forums of the University regarding the introduction of the said supernumerary seats in the Non-AICTE Colleges running in the affiliated colleges. After deliberations with the stakeholders and different forums of the University, the University Authority has decided to allow twenty percent (20%) over and above the affiliating intake per Non-AICTE course in all Non-AICTE colleges affiliated to this University from the Academic Session 2018-2019 for admitting students under the abovementioned categories (i) and (ii). For admission under category (ii) stated above, the extant rules will strictly be followed by the colleges. For introduction of such supernumerary seats colleges are required to pay Rs. 15,000/- per Non-AICTE course as affiliation related fee. During registration process of students under the said supernumerary seats the concerned college has to produce the receipt of remittance of such fee to the Registrar.

All concerned are to note and act accordingly.
