## NOTIFICATION

In continuation of this office Notification No. 947/IC-130/2014 dated 13.05.2014 expressing interalia to intimate the office of the undersigned within 26.05.2014 the processes defined by AICTE (shown in tabular form in the Notification dated 13.05.2014) like adding courses in the existing programme, increase/reduction in intake etc. applied for before the AICTE it is further notified for information of all concerned that in connection with the affiliation for the Academic Year 2014-2015 the University is required to start inspection of the colleges who are applying for new intake of course before the AICTE immediately as the University will have to act with the strict timelines. It is to mention that the University is required to send the intake of all courses in respect of AICTE approved Institutions to the State Admission Authority as per directive to be issued by the State Govt. In this year the work of AICTE approval process has started lately. So it will not be possible on the part of University to start inspection for affiliation purpose of new intake after receipt of the AICTE approval.

In view of the above the University has decided to start inspection immediately after getting intimation from the colleges regarding new intake of course (i.e. within 26.05.2014 as notified earlier) because of the time constraint and the colleges where inspection will be carried out will be intimated over telephone. However it is made clear that for the said time constraint the University may not be in a position to inspect 2<sup>nd</sup> time for affiliation for the Academic Year 2014-2015 if deficiencies are noticed in 1<sup>st</sup> inspection. Affiliation of new intake of any course in respect of any college conducting AICTE approved courses will **only** be considered subject to the fulfilment of the followings:

- (i) AICTE approval for new intake approval of the course along with the extension of approval of the existing courses for the year 2014-2015.
- (ii) Satisfactory inspection report for new intake of the course from WBUT Inspection Team who will visit the college campus.

All other things in this office Notification dated 13.05.2014 will stand in force.


All concerned are requested to note and cooperate with the University so that entire work pertaining to the affiliation for the Academic Year 2014-2015 may be carried out in accordance with the strict time schedule to be prescribed by the State Govt.
