
In view of the above, I am directed to request you to kindly go through the aforesaid communication and ensure the participation of your college.

Dear Prof. Dey,

This is in connection with the State-level Teachers' Convention being organised by the Higher Education Department on Saturday, the 7<sup>th</sup> January 2016 at 2 p.m in the Netaji Indoor Stadium, Kolkata.

You may recall Dr. Partha Chatterjee, Hon'ble Minister's announcement in this regard to the Vice Chancellors and Principals of the State in the Review Meeting held on 17 November 2016, informing that the Hon'ble Chief Minister had graciously consented to address the said Convention, and his appeal to the heads of the State's higher education institutions to participate enthusiastically in the first-ever State-level Teachers' Convention.

Participation in the State-level Convention will be treated as "on duty".

Since time is short, I will be grateful for your immediate action in planning the whole exercise so that it can be smoothly implemented. A team under the Inspector of Colleges or any officer you deem fit may be entrusted with the responsibility of coordinating with the affiliated colleges under your jurisdiction, so as to facilitate their participation too.
