Sub: Uploading of the data in the FIS (Faculty Information System), the First Module and the 2nd module i.e. IIS (Infrastructure Information System) of CWMS.

Dear Sir/Madam,

You were requested to upload the data in respect of Faculty Information System (FIS), the First Module of the Computerized Web Based Management System (CWMS) by using the user account and password vide this office letter Nos. (i) 786/IC-132/2012 dated 04.07.2013 and (ii) 794/IC – 132/2013 dated 26.07.2013 (iii) 797/IC – 132/2012 dated 06.08.2013 (iv) 803/IC-132/2013 dated 03.09.2013, (v) 845(184) dated 07.10.2013 and (vi) 863/IC-132/2013 dated 21.11.2013. In the last reminder letter dated 21.11.2013 the last date of such uploading in the FIS was scheduled on 10.12.2013. On this date we have retrieved the data from the database uploaded from the end of the colleges and the observations are stated hereunder in seriatim.

- 1) A few colleges are yet to upload any data in respect of their college.
- 2) A few faculty members of some colleges have made the attempt to upload the data but they have not completed some fields like personal details, academic details etc.
- 3) A few faculty members of some colleges have uploaded the data but remaining faculty members being the major part of those colleges have not started the uploading of their data.

As per WBUT First Regulations, the affiliation of the college is accorded on a yearly basis and continuation of affiliation of existing courses in an existing college in subsequent years is subject to scrutiny by the University. The University Authority has decided to accomplish the said scrutiny work through the Computerized Web based Management System (CWMS) consisting of three modules namely; Faculty Information System (FIS), Infrastructure Information System (IIS) and Web based Management System (WMS). In spite of the **several reminders**, it is observed that a few colleges are not giving priority to upload the data in the FIS.

After expiry of the date of the uploading in the FIS i.e. 10.12.2013 a few affiliated colleges had requested to extend the last date upto 15.01.2014. After careful consideration of the matter the last date of uploading in the FIS is extended upto 15.01.2014. However, the date of uploading in the 2nd Module (IIS) i.e. 15.01.2014 will remain unaltered.


You are once again requested to upload the data in two modules i.e. FIS and IIS. It is to be mentioned that the account will be suspended after expiry of stipulated time mentioned above.
