Sanction is hereby accorded for a sum of Rs. 34,51,494/- (Rupees Thirty four lakh fifty one thousand four hundred and ninety four) only for execution the following scheme shown in Table under M.P.L.A.D.S on recommendation by Prof. Pradip Bhattacharya, Hon'ble M.P. (R.S).

Now, 75% of the sanctioned amount shall be released against Sl. No. 1 i.e. Rs. 25,88,621/- (Rupees Twenty five lakh eighty eight thousand six hundred and twenty one) only.

The Name of the Executing Agency i.e. Registrar, Maulana Abul Kalam Azad University of Technology (MAKAUT), West Bengal should be selected for execution of the following scheme and the amount released for the scheme is shown against the scheme in Col. No. 3 & 5 of the following Table.

The M.P.L.A.D.S Guidelines and West Bengal Financial Rules Vol-I & Vol-II of Govt. of West Bengal are to be followed strictly by the Executing Agency for utilization of fund. The scheme (MPLADS) of Rs. 5.00 lakh and above should be executed through e-tender process. Tender should be invited for 100% of the work after observing all Govt. formalities and work order should be issued accordingly.

No contingent expenditure, no overhead expenditure, no agency charge, no advance to contractors, no purchase of inventory or land or machinery, no recruitment of staff can be made out of the allocated amount.

The fund must be kept in any Nationalised Bank by opening a separate Savings Bank account (MP wise) in favour of Rajya Sabha and the interest accrued on the fund must be refunded to the District Authority



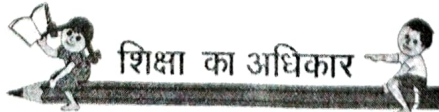
The Technical Education Quality Improvement Programme (TEQIP) commenced in 2003 with World Bank assistance as a long term programme to be implemented in three phases.

- TEQIP-I commenced in 2003 and ended on March 31st, 2009 covering 127 institutes (including 18 CFTIs across 13 States).
- TEQIP-II commenced in August 2010, covering 23 states/Union Territories (UTs) and 191 institutes (including 26 CFTIs) and ended on 31st March, 2017.

2. Both projects have had a positive impact on the infrastructure and educational standards in the technical institutions where they were taken up.

3. The Third Phase of Technical Education Quality Improvement Programme (TEQIP) has been approved by the Government of India to be implemented as a 'Central Sector Scheme' with total project outlay of Rs. 3600 crore. However, the Project is being initiated with an initial cost of Rs. 2660 crore.

4. Under Sub-Component 1.3 of TEQIP-III, the Affiliated Technical Universities from non-focus states will be selected competitively and twinned with about 3 ATUs of focus states to build capacity and improve performance. Also, a major part of the project is for improving the standards of education in the private technical institutions also through the interventions by the Affiliating Technical Universities (ATUs).
