# SPORTS POLICY, MAKAUT, WB., 2022

## 1. THE PREAMBLE

Sports Policy, MAKAUT, WB. 2022 is framed in accordance with the spirit of National Sports Policy, 2021, which affirm that Sports activities are essential components of human resource development, help in promoting good health, comradeship and the spirit of friendly competition, which, in turn, has positive impact on the overall development of personality of the individuals. Distinction in sports enhances the sense of accomplishment, national pride and patriotism, providing beneficial recreation, improve productivity and foster social harmony and discipline.

The Sports Policy will be based on "Broad-basing" of Sporting activities amongst the students and "Achieving Excellence in Sporting activities at University (Inter-Intra), State, National and International levels".

## 2. OBJECTIVES

1. To provide equal opportunity to all students of the University to participate in sporting activities,
2. To promote awareness about the benefits of Physical Education & Sports and to spread Sports Culture among students,
3. To encourage students to take part in University/State/National/International sporting events,
4. To plan, design and construct sports facilities in the University campus,
5. To promote excellence in sports,
6. To provide Incentives and bestow Awards to Sportspersons to maintain sustained interest among students to participate and perform progressively,
7. To Develop Adequate and Standard Sports Infrastructure Facilities like Playing Fields, Gymnasium, Swimming Pool, Track & Field, and procure Quality Equipment,




8. To provide Systematic Coaching Programme by involving Qualified & Competent Personnel to groom University Teams & Sports Talent.

### 3. RULES AND REGULATIONS

1. Participation in a sports activity at the University shall be voluntary. Therefore, every student/player shall be responsible for his/her safety and the safety of his/her fellow students. The University shall not provide health insurance to cover participants during university sports.
2. Every participant assumes sole responsibility for any and all such risk or injury that may result due to his/her voluntary participation. Therefore, the University shall not responsible for injuries sustained while participating in any sporting activity of the University
3. Every participant in the sports activities organized by the University shall understand and acknowledge that the use of equipment and facilities provided by the University must be handled with care.
- 4., Participants shall not interfere with employee duties, use obscene language, or engage in verbal and/or physical abuse of employees or other participants.
5. Participants must observe all posted signs and verbal directions provided by the University
6. No participant shall be allowed to use of drugs, alcohol and tobacco products at sports activity venues.

### 4. ELIGIBILITY OF PLAYERS

1. All currently enrolled students of post-graduate students of the University and undergraduate students of the affiliated colleges of the University are eligible to participate in the sports events/activities of the University.
2. The participants of the events/activities must' present their University issued ID before each contest in order to participate in any sports activity/ event.
3. All coaches, team captains, and bench personnel must be on the team roster and meet sports eligibility criteria of the University.
4. Any team found using a player that is playing under a fictitious name or ID will forfeit all games in which that player checked-in. The player using an improper ID and the player providing the ID to be used illegally will be suspended. The team captain may also be suspended at the discretion of the University.





5. Unauthorized use of a University issued ID will result in confiscation and/or university disciplinary actions.

## **5. DISCIPLINARY PROCEDURE FOR UNSPORTSMANLIKE ACTIVITIES**

1. The players in any sports activity/event who choose to follow unsportsmanlike practices before, during, or after a contest, whether directed towards staff, an official, an opponent, or a spectator may be expelled from that contest.
2. All players are expected to follow the Code of conduct before, during, and after participation in the sports activity.
3. Any player who is believed to be under the influence of alcohol or drugs will not be permitted to participate or remain at the sports event or site of event. Players consuming alcohol and/or drugs, or who have consumed alcohol and/or drugs before a contest will risk forfeiture of the game and may be expelled from further play.

1. To formulate Sports Policies, frame Rules & Regulations of Physical Education & Sports Programme from time - to - time,
2. To suggest measures for Promotion of Sports Activities,
3. To suggest measures to carry out the Sports Activities according to the University Budget Allocation and Allocation of University Sports Development Fund for Sports Activities & Development Programmes,
4. To frame the Guidelines and Policy Document for Admission of Students under "Sports Quota" in the University and Affiliated Campus,
5. To frame the guidelines for awarding sports scholarships to outstanding sportspersons of university,
6. To ascertain/revise the entry fee for utilization of various sports facilities (such as gymnasium hall, and other sports grounds) from time- to- time,
7. To approve the names of suitable External Experts, Physical Education and Coaching Professionals to serve on Various Selection Committees for Selecting Sportspersons for University Teams.
